## Introduction

Children are exposed to multiple vulnerabilities. The forms of violence against children such as child sexual abuse, child marriage, physical violence at home etc is on n increase. India is home to the largest number of sexually abused children in the world with a child sexually abused every 15 minutes (NCRB). Failure to protect children from issues such as violence in schools, child labour, harmful traditional practices, child marriage, child abuse, the absence of parental care and commercial sexual exploitation, amongst others, means failure in fulfilling both the Constitutional and International commitments towards children.

The main causes contributing to the violence against children are: weak system (institutional mechanism) with lack of implementation of the laws and policies, lack of skill and efficiency of the child protection workforce and ignorance of children, parents and care givers.

#### The objectives of this program are

To work with children in slums and schools:

- > To understand Child Rights and Child Protection
- To understand safe and unsafe touch and how they can report it if they have experienced it
- > themselves or a friend has experienced it
- To understand online safety for themselves and their parents
- To understand reporting mechanisms for online safety

#### To talk with adults of the community in 4 slums:

- To help parents understand the need for protection of their children, understand the signs of
- violence and sexual violence in a child.
- ➤ How and who to report cases of child sexual abuse of their own children or children in their community
- To understand online safety for themselves and for their children

#### To work in two wards

- > To strengthen and build on ward level child protection committees, so that all children in
- their wards are safe from child labour, begging, child sexual abuse and physical abuse
- > To understand their role in the protection mechanism for children under the VATSALYA
- program.

# **ACTIVITIES**

## 1. Reaching Children in Schools



**Government Primary School Bnjarawalla** 

Through the program we reached over 4949 children in 62 schools. Discussions were held on child rights through that each child's right to protection and safety.

Children were taught about on online safety. It included raising awareness about phone addiction through two short cartoon movies and providing information on where to lodge complaints in case of fraud or online harassment. A pamphlet that discussed the importance of **Connect** – who we should connect with, **Content** – What content we should post, **Conduct** –

what our conduct should be online and **Commerce** – How we can keep our selves safe from online fraud.

The younger children learnt about safe and unsafe touch with through a cartoon movie and helped the children understand who their "body guard" could be. The team also discussed emotions with the children and how the children must listen to their emotions in order to keep themselves safe because our body and our emotion always tell

us when we are unsafe we just have to listen. They were taught about safe and unsafe touch via a poem that they memorized. They remember the safety numbers like 1098 and 1090

Details were shared about the Juvenile Justice Act as well as the POCSO Act

Since the children were mostly from government schools in Dehradun child labour was also

discussed and that each child's right was to go to school and not work in any house or in any dhabba, restaurant or farm. The children were told to see around them at home if there was any child who was working, as they were

granted protection under the prohibition of child labour and the services that the children could get

under the act including sponsorship funds. The team promised to help any child who needed admission or wanted to stop working.

At the end of the sessions the children were reminded about their bodyguards and were taught to remembered the cyber complaint number 1930, and were reminded of safe-unsafe touch. They were informed about how to respond if someone touches then in an unsafe manner or makes them feel unsafe.

## 2. Bal Sangathans

Four Bal Sangathas or children's groups were made in 4 slums. TapriBasti, Gandhi Gram, Shastri

Nagar and Macchi Talaab. These children are from a diverse back ground and typically come from east UP and Bihar and are migrant, they often leave of their home states for months at a

time. Child marriage and child labour is prevalent in their home states and tends to find its way here as well. The community is basically daily wagers where the men often are labourers in construction and the women work in homes - washing, cleaning, sweeping etc.

To start with the team visited several slums to find four that they could work in effectively. They met with the adults and the

children in the bastis. They asked the adults if they would be interested in sending their children to meetings at least once a month.

The team then visited each house and invited the children to com eto a place where they would play some games. Once the children started enjoying the games they would come readlity to the meetings. They were told about the formation of a bal sangathan (children's groups) and what it meant. The children then helped decided the venue for the meetings.

44 monthly meeting have been held with these children one a month after the sangathans were formed, 1777 children attend these meetings regularly and sometimes even more children come to these meetings. We have found that children are abused in bastis by people who they know well so it was imperative to tell them about safe and unsafe touch and how they should react. The topics they discussed in their balsangathans were are safe and unsafe touch, how much information they should

share with strangers. Who their body guard or trust

Bal sangathans or children groups were formed in 4 bastis. Saraswati Bal Sangathan, in Macchi Talab, Ekta Bal Sangathan, in TapriBasti, Everest Bal sangathan, Shastrinagar and Basant Bal Sangthan in Gandhi Gram.

worthy person is, how to keep themselves safe online and offline. They also discussed child rights and child participation. The children also discussed issues of safety that they faced in their bastis.

A small quiz<sup>1</sup> was played with the children to understand their knowledge of child rghts, safety and phone numbers that they could call at the time of emergencies

Many children from Machhi Talab basti would change very few months as their parents would migrate to another part of the city or go to another city. In order to understand where these migrant labourers were coming from we created a tree where children wrote thei native village was and a phone number that they could be reached at.

#### The Impact

In Tapri basti the older girls initially wouldn't attend the bal sangathan meetings but slowly they realized that interesting issues were being discussed and started attend the meetings.

Parents send their children to the Bal sangathan meetings and sometimes even stay and listen.

Children are able to use the safe and unsafe touch chart to explain to other children how to stay safe

The children from Everest Bal Sangathan

celebrated the first international day of play on the 11<sup>th</sup> of June. They understood how important it was for each child to have the right to play. They also discussed the games they would traditionally play.

**Reema, Ekta Bal Sangathan, Tapri Basti**: In the organization's home, there should be space for another gender, such as transgender individuals.

**Deepak, Gandhi gram Basant Bal Sangathan**: He said that when I was taught to make bags from newspapers on Environment Day, I used that at home to bring back items.

Madhuri, Ekta Bal Sangathan, Tapri Basti: She mentioned that if meetings are not held regularly, children will lose the habit of attending and will forget everything.

Chhavi, Ekta Bal Sangathan, Tapri Basti: She stated that she looks forward to the meetings. In the meetings, we get a chance to express our opinions. I have started speaking openly now.

**Bhavna, Everest Bal Sangathan, Shastrinagar**: She said that we want to hold a rally against drug abuse again so that people can be made aware and the problem of drugs can be eliminated.

**Mr Deepak, Father, Machhi Talab:** It is very important to keep reminding children about safe and unsafe touch. You are doing good work for our community

**Ruso Devi, Mother ,Gandhigram:** My children enjoy attending the meetings. They have been educated about safe and unsafe touch.

**Ragini, from Everest Baal Sangathan, Shastrinagar:** expressed her pleasure in attending the meetings. She found it a great opportunity to learn new things.

## 3. Community Meetings

4 bastis were selected to work in. These communities are from a diverse back ground and typically come from east UP and Bihar and are migrants. They often leave their home states in search of a better livelihood. The community is basically daily wagers where the men often are labourers in construction and the women work in homes — washing, cleaning, sweeping etc. Child marriage and child labour is prevalent in their home states and tends to find its way here as well. The community is not stable and will travel back to their home state for months at a time. A venue was selected with the help of the women where they monthly meetings could be held. 44meetings were conducted with 1297 participants mostly women. The team gathered information as to what their issues were relating to the protection of their children and issues they face. Safe an unsafe touch was discussed with the women as the team has seen that safety was an issue in the bastis.

A discussion was held with them on the online safely and on the advantages and disadvantages

of the internet. They were told that banks never ask for pin numbers on the phone from their consumers.

Discussion on hygienic and safe menstruation was held with the women said that they were

accessing sanitary napkins at the anganwadis and the janaushadhi kendras at a low cost but were concerned about the bad quality and small size of the sanitary napkins,

for which a complaint was filed.

Discussions were held on sending children to schools. Separate meetings were held with

parents whose children were not attending school regularly and they were motivated and 06 children are now going to school regularly.

The women were also told about the sponsorship scheme that is for children who are from poor families. This sponsorship fund is provided by the women empowerment child development and is a cash benefit to help child access nutritious food or to go to school or whatever the family needs.

During one meeting in Gandhi Gram the women mentioned about a young woman who had been abandoned by her husband and was facing many problems at home, including a lack of food supplies. After assessing her situation, the MCF provided her with ration for a month. The team also submitted her documents to the district probation office for the sponsorship scheme for her children.

The Impact of our meetings and trainings can be seen in the responses we have received from

the women in the Bastis. They feel safe enough to ask questions and share information

#### FeedBack

**Mrs. Neelam Devi, Shastrinagar** - My daughter, Kshish, comes home and tells me about safe and unsafe touch.

Mrs. Saroj Devi, Gandhi Gram - I talk to my granddaughter about safe and unsafe touch. I have told her

that if she has any problems, she must inform me and others at home. Now, my grandson and granddaughters always inform us when they go out, and since they are still young, we do not send them out alone.

Mrs. Priya Hira, Shastri Nagar - She mentioned that when I sit with my phone while talking to someone, ads start appearing on my phone. But now I understand that I shouldn't keep the internet on all the time. I will only keep it on when necessary.

Mrs. Pooja, Shastri Nagar - She said that my daughter goes to a children's organization meeting, and the activities the lady there teaches them are also done at home. She makes a chart and gathers the little kids for their meeting at home.



Mrs. Sonu Devi, Machhi Talab - She stated that during Gandhigram, Community Meeting menstruation, they still don't let her go to the temple. In

response, Reena Devi said that when I have my period, my mother-in-law gives me separate food; I can't eat with everyone.

Mrs. Sangeeta, Shastri Nagar - If we feel threatened anywhere, we should inform everyone about it so that others can remain safe.

Mrs. Rajeshwari, Shastri Nagar - She reported that she received a fraud call asking for an OTP. However, my son filed a complaint about it.

Mrs. Asha, Tapri Basti - She mentioned that now we know that if someone commits fraud related to money, we should complain to 1930.

Mrs. Gyaani Devi, Shastri Nagar - said that just like the children held a rally against drug abuse, we also want to

organize a rally to inform people about the harms of drug abuse

Mrs. Seema Devi, Tapri Basti - While providing information about labour cards in the community, she mentioned that they benefit from this scheme. She has also received a sewing machine under this scheme.

Mrs. Vibha, Machhi Talab - She said that they are forced to make their children work due to their poverty; otherwise, we too would also like to educate them.

Mrs. Vinita from Machhi Talab said that she will not to return to Bihar until her daughter turns 18. She said that the prevalence of child marriage was high there and also there was high societal pressure to marry daughters while they were minors.

Mrs. Saroja Devi from Gandhigram said that she now discusses her grandchildren's daily routines with them at home and advises them not to take anything from anyone.

Mrs. Habiba from Shastrinagar said that she now pays attention to what her children are watching on their phones when she gives them the phone.

## 4. Child Protection Committees



Under the Mission Vatsalya, ward-level child protection committees were formed in Shastri Nagar Ward No. 42 Kawanli, MachhiTalab Ward No. 41 Shastri Nagar SeemaDwar, TapriBasti Ward No. 71 Eastern Patel Nagar, and Gandhi Gram Ward No. 43 SangamVihar.

Meetings were held 04 settlements, attended by 129 members of the committee 28 men and 101 women.

The meetings gave information about the objectives, functions, and responsibilities of the child protection committees was provided through a PowerPoint presentation.

The meeting was attended by councilors, Anganwadi workers, school principals, the protection officer DCPU, child welfare police officers, ICDS supervisors, labor enforcement officers, AENAM, members of child organizations, members of the school management committee, representatives of the child helpline community, and DLSA.

#### **Shastrinagar:**

- Sarla Devi, a social activist from Shastri Nagar, reported that people sit and consume substances until late at night, disturbing others.
- Bhavana, a member of the Everest BalSangthan in Shastri Nagar, mentioned that some individuals near the cemetery use drugs and harass girls during school hours.

The WLCPC submitted a written complaint to the local police station, the SSP, and the DM. Following the complaint, the police is now patrolling the area.

#### Machhi Talab

 Chanda, a member of the Saraswati Bal Sangthan from Machhi Talab, stated that adults in the neighborhood gamble, negatively impacting the children.

The WLCPC submitted a written complaint to the local police station, the SSP, and the DM. Following the complaint, the police is now patrolling the area.

## Tapri Basti

Rima, president of the Ekta Bal Sangthan in Tapri Basti, noted that shopkeepers sell bidis and cigarettes to adults, which leads young children to purchase these items, thereby learning to use substances.

 Sonu, of the of Ekta Bal Sangthan in Tapri Basti, shared that garbage trucks do not come to their area, causing residents to dump garbage into the drains.

 Hemavati Joshi, the principal, stated that factories located behind the school release smoke into the school, causing children to fall ill and vomit.

The WLCPC submitted a written complaint to the Deputy Labour Commissioner and the DM and Chief Education Officer. The complaint is being followed up on.

#### **Gandhi Gram**

 Anshu, member of the Basant Bal Sangthan in Gandhigram, reported that both children and adults gather at Sadhuram Inter College to use drugs, destroying the safe environment.

The WLCPC submitted a written complaint to the local police station, the SSP, and the DM. Following

the complaint, the police is now patrolling the area.

#### **Impact**

- Mrs. Gyan Devi from Shastri Nagar reported that one day while passing near the
  government primary school in Shastri Nagar, she saw some people using drugs in the
  school. They thought the police were on patrol again, so they all fled from there. The
  complaint made after the CPC meeting had the effect that now anyone who comes
  there causes those sitting in the school to run away.
- Bhavana, a member of the Everest Bal Sangthan from Shastri Nagar, mentioned that during the meeting, when the issue of the cemetery road was raised, a complaint was made to the police. After that, the police came for a patrol, and now the children have stopped using that route.

#### **Feed Back**

- Chanda, a member of the Saraswati Bal Sangthan from Machhi Talab, stated that a wardlevel child protection committee is necessary so that children's issues can be addressed. There will be discussions about safe and unsafe interactions with children, allowing them to express their concerns freely.
- Mrs. Archana Pundir, a councilor from Shastri
   Nagar, said that any issues that arise in the meeting will be reported to the relevant departments through the committee to find solutions.
- Mrs. Amita Dagwal, an Anganwadi worker from Tapri Basti, emphasized the importance of the committee. In meetings, people can express their views without fear, and together they can find solutions to problems, so the burden does not fall on just one person.

- The protection officer from DCPU stated that if any issue arises, there should not wait for the meeting; but efforts should be made to resolve the problem immediately by the committee members.
- Hemavati Joshi Principle Government
   Primary School Patel Nagar, thanked the
   MCF and stated that people from all
   departments should be gathered in one
   place to discuss children's issues.
- Sashi Purohit, a child welfare police officer from Vasant Vihar Police Station, said that regarding the drug issue at Sadhuram School, they will increase police patrols.

- Rachna, an Anganwadi supervisor from
   Gandhigram, mentioned that it was great that people from all departments were present at today's meeting. If everyone continues to attend, the issues can be resolved.
- Former councilor Sonu Kumar from Gandhigram emphasized that promoting the child protection committee is very important so that people are aware of it and can offer help.

#### 5. Stories of Change

#### **Success Stories**

- During the Shastri Nagar community meeting, Lakshmi shared that she went to the government primary school in Shastri Nagar to enroll her daughter, Janvi, who is 6 years old, in class 1. However, the school principal said that the girl would first have to take a test. If her marks were low, she would not be admitted to class 1. Hearing about the test made her daughter anxious, resulting in her getting poor marks. Consequently, the school refused to admit her daughter. Following this, the MCF team informed the mother that the school could not deny admission to her daughter, as it was a violation of the Right to Education. If they continued to refuse, she could file a complaint. The team helped the mother call the 1098 Child Helpline, and a complaint was lodged regarding the school's refusal to admit her. The very next day, the teacher from the school called the girl's parents and said that their daughter would be admitted. Thus, the school admitted Laxmi into class 1.
- In the Machhi Talab community meeting, Mrs. Vinita, said that she went to the government primary school in Dhandar for her son Shiva's admission. However, the school authorities claimed that they could not admit him due to an excess of students. Following this, the MCF team visited the school and spoke with the principal about the admission. They requested the admission of the child under the Right to Education and informed them about the family's circumstances. After discussions, the principal agreed to admit the child and asked them to bring Shiva and his family to the school.

Subsequently, the Shiva's family went with him to the school and successfully enrolled him in class 1.

- During the Machhi Talab community meeting, Mrs. Kamini, shared that she also visited the government primary school in Dhandar for her son Sunny's admission. The school authorities similarly stated that they could not admit him due to a high number of students. The MCF team visited the school and discussed the issue with the principal. They again requested admission for the child under the Right to Education and explained the family's situation. The principal agreed to admit the Sunny after the discussion and said that they could bring the child and his family to the school. The child's family then went to the school and enrolled him in class 1.
- During a community visit to Machhi Talab, it was discovered that Shivani, aged 10, was not attending school as she was taking care of her younger brother. The MCF team spoke to her parents about sending Shivani to school. They outright refused to enroll her, stating that both parents worked and she needed to stay home to care for their younger son. The team continued to contact them for about three months and encouraged them to enroll the girl in school. After significant persuasion, Shivani's mother, Reshu Devi, agreed to enroll her. She successfully admitted her daughter to the government primary school in Harbanswala in class 2. Currently, the girl is attending school regularly.
- During a community visit to Gandhigram, it was discovered that a girl named Gunjan, aged 12, was not attending school. The team visited her home to meet her. When asked about school, she expressed her desire to attend but mentioned her responsibility for her younger siblings. She stated that her parents both worked, which prevented her from going to school. The facilitators spoke to Gunjan's mother and explained the importance of education. They suggested sending the younger son to the Anganwadi center and the older children to school, assuring her of assistance in enrolling the children. The team maintained regular contact with Gunjan's mother, encouraging her to enroll her children in school. Initially, Gunjan's mother hesitated, but after about 6 to 7 months of constant follow up, she agreed to enroll the children. Consequently, Gunjan was admitted to class 6, and her sister Anjali was admitted to class 5 at the Arya Samaj Mandir in Lakshman Chowk. Gunjan now takes her one-year-old brother with her to school.
- During the MachhiTalab community meeting, Krishna Devi mentioned that her daughter Preeti was 4 years old. She wanted to enroll her daughter in the Anganwadi center, but the Anganwadi worker refused to register her because she was malnourished. Subsequently, the facilitators spoke to the Anganwadi worker at the center, requesting she register of the child in her anganwadi. The Anganwadi worker stated that there were already 36 children registered at the center and that no more could be admitted. She assured the facilitators that she would register the girl in July. At the July community meeting, the girl's mother confirmed that her daughter had been registered at the Anganwadi center and that she was going to the anganwadi daily. She thanked the team for facilitating the admission.
- Pawan Devi of MachhiTalab now proudly signs the meeting register. She initially used to put her thumb impression instead of signing her name. The team motivated her to learn

how to sign. Now, Pawan Devi has started writing her name instead of using her thumb impression

- During the community meeting at the MachhiTalab basti, the issue of teacher shortages in the primary school was raised. The MCF team visited the Govt. Primary School in Dhandaarand discussed the shortage of teachers in the school. They found that the school had a high number of students but a shortage of teachers. The team helped the community members to file a complaint on 1098 the child helpline. As a follow up to that the DPO Dehradun, sent a letter to the Education Department. As a response to the letter, the education department made arrangements for teachers in the school, making the children and their parents very happy. When the team visited the Macchi Talab basti, the children expressed their gratitude for the help given in bringing teachers to their school.
- The Anganwadi center in Gandhigram was visited multiple times. No meetings could be conducted in the anagnwadi because it was always closed. The team discussed this fact with the anganwadi worker, who it was found was on BLO duty and assigned to another location. She had told the anganwadi helper to open the anganwadi every day which she was not doing. The Anganwadi worker assured the facilitators that she would contact the anganwadi helper herself. The next day, the Anganwadi center was found open, and the anganwadi helper was also present there.


